

# Northern Lites Rally presents.....Frost Heave Rally, March 12, 2005

**Frost Heave** will be a straight-forward Time-Speed-Distance rally of approximately 140 miles. A tulip diagram format will be used for the route instructions! This rally is well suited for inexperienced as well as veteran rallyists. **Frost Heave** will start and end in Loudon/Concord, New Hampshire and wind its way over hills and along lakes and rivers, touring scenic central New Hampshire back roads. Paved and unpaved roads are utilized, however, depending on the weather; you may not know the difference. The rally is hosted by the New England Region of the Sports Car Club of America (NER/SCCA).

**General:** Frost Heave will be run in compliance with the 1996 NER-SCCA Rally Regulations as amended. General Instructions will be posted on the NER website, and mailed to teams only if requested.

*Saturday*, June 26, 7:00AM-8:30AM at the Red Roof Inn.

**Novice School:** 8:00-9:30PM Friday night at the Red Roof Inn. You must let the rallymaster know you are coming.

**Lodging:** The Red Roof Inn, Loudon, NH. Take exit 15 off I-93, onto I-393 East, then Rt. 106 North (follow signs towards the speedway). Continental breakfast and an indoor pool included with lodging. There is a block of rooms reserved until Feb 25th at a discounted rate of \$59.49 + tax, double occupancy.
